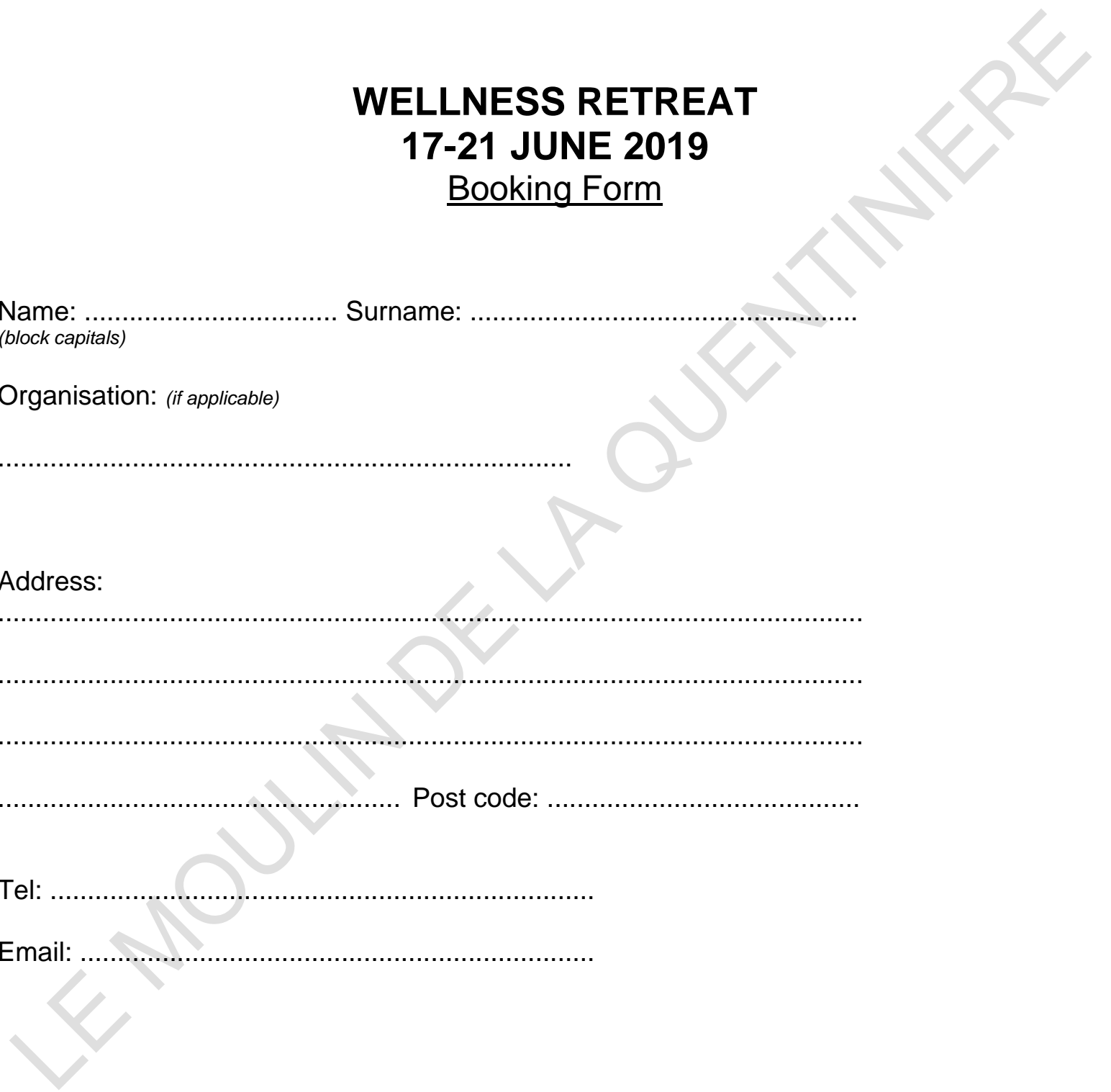

## TERMS AND CONDITIONS

### 1. GENERAL

- (a) "LMQ" – Le Moulin de la Quentinière
- (b) "You / Guest" – the person making the booking and named on the booking form
- (c) "event period" – the duration of the event

### 2. PAYMENT

- (a) Non-refundable booking deposit of 10% once booking has been confirmed in writing.
- (b) Balance of event fee is payable 30 days prior to the event date.

### 3. CANCELLATION

- (a) In the event of cancellation of the booking, the Guest agrees to inform LMQ in writing not less than 30 days prior to the event date or a cancellation charge will become payable. Cancellation will take effect the day such notification is received and acknowledged by LMQ.
- (b) As LMQ incur third party costs, LMQ will retain your booking deposit and, in addition, may apply cancellation charges up to the maximum shown below:
  - (i) Days Before Start Date Cancellation Charge:
    - Greater than 60 days: deposit only
    - 30-60 days: 75% of event cost
    - less than 30 days: 100% of event cost
- (c) LMQ reserves the right to cancel events with reasonable notice without loss or penalty. In any such event, any monies paid will be refunded.

### 4. BOOKING PROCEDURE

- (a) If the booking is made 10 or more weeks in advance of the event date, payment of a non-refundable deposit of 10% of the advertised event cost will be due.
- (b) Where a deposit has been paid, a final request will be sent to you approximately 10 weeks before the event start date and payment of the balance of the event cost will become due 8 weeks prior to the start date. If the balance of the cost of your place at the event is not paid on time, LMQ reserve the right to cancel your booking, retain your deposit and apply the Cancellation Charge set out in Paragraph 3 above.
- (c) For bookings made within 10 weeks of the start date, the full payment will become due immediately upon confirmation of the booking. Once payment has been made, any subsequent cancellation will incur Cancellation Charges as set out in Paragraph 3 above.
- (d) Your booking will only be considered definite once LMQ has issued a confirmation email to you. No contract will exist between you and LMQ prior to LMQ issuing a booking confirmation email.

### 5. EVENT COST

The event cost includes: one return airport transfer (as applicable and terms apply), accommodation (where applicable), all drinks and meals, treatments as advertised and all group yoga classes, unless stated differently in your booking confirmation email. Our prices specifically exclude flights, travel insurance, airport and/or any other transport and transfers unless otherwise stated.

### 6. CANCELLATION BY US

- (a) LMQ reserves the right in any circumstances to cancel your event at any time up to 4 weeks before the start date, in which case LMQ will offer a refund in full of all monies paid. LMQ will not be responsible for any monies you have paid for travel, so please ensure you have adequate travel and cancellation insurance in place at the time of booking.

### 7. Please note:

(a) Refund payments will not apply if payment for the event has not been received by LMQ within the payment guidelines set out in Paragraph 1.

(b) Refund payments will not be paid if LMQ is forced to cancel or in any way change your event due to force majeure such as, but not limited to: war, threat of war, riot, civil strife, industrial dispute, terrorist activity, natural or nuclear disaster, fire, adverse weather conditions, technical or maintenance problems with transport.

#### 8. TRANSPORTATION, PASSPORTS, VISAS, AND INSURANCE

LMQ is not responsible for your individual travel plans, such as flights and or other transport arrangements to or from the event location. You are responsible for ensuring that you have valid documentation for travel, such as a passport, and any necessary visas and or required inoculations and adequate travel and cancellation insurance.

#### 9. LMQ'S LIABILITY TO YOU

(a) LMQ accepts responsibility for ensuring that the events that you book with LMQ are supplied as described and that the services LMQ is contractually obliged to provide are to a reasonable standard.

(b) LMQ does not accept responsibility for the acts and/or omissions of the employees, agents and suppliers in particular where they lead to death, injury or illness (see below).

(c) LMQ is not responsible for acts and services provided by the suppliers and sub-contractors, servants and/or agents whilst acting within the scope of, or in the course of their provision of your event who may in the course of providing acts or services are responsible for death, injury or illness caused by negligent acts and/or omissions.

#### 10. DISCLAIMER

As there are inherent risks with any physical activity retreat and with exercise such as yoga, LMQ recommended that you consult your doctor, prior to booking your retreat, to advise you on your ability to undertake strenuous exercise. You are required to make LMQ aware of any medical condition which may affect your ability and comfort when undergoing vigorous exercise by completing the PARQ form. (Any information on the PARQ form will be kept confidential and will only be used for consultation for the provision of services at the event).

#### 11. COMPLAINTS

If you have a problem during your retreat, please inform a member of the LMQ team immediately.

#### 12. BEHAVIOUR

Guests who are deemed to be acting in a way that is inappropriate towards our local teams or other group members may be asked to leave. No refund will be given in these circumstances.
